Bridge Replacement

The Oklahoma Department of Transportation (ODOT) has submitted an Agreement for the Council consideration to replace the bridge over Stinson Creek on EW-1240 (west of Oklahoma State Highway 76) on 85th NW.

The cost of the bridge replacement is estimated at \$951,123 and will be paid for by the state at 100%.

National Airborne Day

August 16th is a day designated by the United States Congress to honor the nation's airborne units of the armed forces. It was created in 2001 by President George W. Bush. August 16, 1940 marked the first official Army parachute jump, validating the innovative concept of inserting United States ground combat forces behind a battle line by parachute. During World War II, airborne tactics were critical to the success of important missions, including the D-Day invasion at Normandy, the Battle of the Bulge, the invasion of Southern France, and many others. In Korea and Vietnam, airborne soldiers played a critical combat role, as well as in later conflicts and peacekeeping operations, including Panama, Grenada, Desert Storm, Haiti, Somalia, and the Balkans. Most recently, airborne forces were vital to liberating the people of Afghanistan from the repressive and violent Taliban regime; and these soldiers continue to serve proudly around the world in the global coalition against terrorism.

The elite airborne ranks include prestigious groups such as the 82nd Airborne Division, "America's Guard of Honor," and the "Screaming Eagles" of the 101st Airborne Division (Air Assault).

Paratroopers in the Army's XVIII Airborne Corps, the 75th Infantry (Ranger) Regiment and other Special Forces units conduct swift and effective operations in defense of peace and freedom.

Airborne combat continues to be driven by the bravery and daring spirit of sky soldiers. Often called into action with little notice, these forces have earned an enduring reputation for dedication, excellence, and honor. All citizens are encouraged to recognize the contributions of these courageous soldiers to our Nation and the world.

Senior Nutrition Center

The Blanchard Senior Nutrition Center serves a fully balanced lunch (entrees, sides, desserts, tea and coffee) for all senior citizens five (5) days a week beginning at 11:30am, Monday thru Friday (except City Observed Holiday).

If you are 60 or older, you are eligible to participate free of charge. However, a suggested donation of \$2.00 is requested to insure the continuance in meeting the nutritional needs of our elderly citizens.

Citizens under the age of 60 may participate but are required to pay \$5.00 for the meal.

Tall Weeds & Grass



The City of Blanchard is committed to adopted regulations concerning the abatement of tall grass, weeds and trash.

The Blanchard Municipal Code concerning public nuisances and property enhancement requires that owners or responsible persons of property located within the municipal city limits are prohibited from allowing debris, junk, waste or trash to accumulate, or weeds or tall grass over twelve (12") inches in height, dead trees, bushes, and shrubs to grow or stand upon the premises. This regulation is based upon the Oklahoma State Law Title 11, Section 22-111 which sets forth the procedure and definitions for the cleaning and mowing of property.

Property that abuts against public property (ie: alleys, streets, etc.) are responsible for the maintenance and upkeep of mowing of tall weeds and grass, trees, etc.)

Water Rationing

REMINDER! The City of Blanchard receives 100% of our water from the City of Oklahoma City. As a result, we are on a full-time water rationing of odd-even days, as required by our Agreement with Oklahoma City.

This means if your address ends in an even number then you can legally water on the 2^{nd} , 4^{th} , 6^{th} , 8^{th} , 10^{th} , 12^{th} , 14^{th} , 16^{th} , 18^{th} , 20^{th} , 22^{nd} , 24^{th} , 26^{th} , 28^{th} , and 30^{th} of each month.

If your address ends in an odd number, then you can legally water on the 1^{st} , 3^{rd} , 5^{th} , 7^{th} , 9^{th} , 11^{th} , 13^{th} , 15^{th} , 17^{th} , 19^{th} , 21^{st} , 23^{rd} , 25^{th} , 27^{th} , 29^{th} , and 31^{st} of each month.

Weatherization Assistance

PSO offers to its customers a 'Home Weatherization Assistance Program'.

Homeowners and renters with an annual household income of \$55,000 or less in a home less than 2,200 square feet and built prior to 2010 may be eligible for FREE home upgrades such as attic insulation, air and duct sealing, and more.

PSO's service provider, Titan ES, will perform an energy assessment at your home. If your home qualifies, Titan will schedule and complete the necessary home upgrades.

The services are completed at NO cost to you. PSO pays Titan ES for any approved upgrades completed on you home.
