

## City of Blanchard Residential Building Permit – Page 1

**All** building permit applications must be submitted with the following information:

Warranty or Quit Claim Deed – must include book and page number.

- -If property is not in a platted subdivision, the deed must be either
  - (a) five years or older OR
  - (b) submitted with evidence regarding legal lot split approval
- -If not the legal owner of the property, written and notarized permission from the legal owner(s) of the property must accompany the application

**Complete Set of Building Plans** – a full set must also be kept on the construction site at all times

**Easements** to access the property, if applicable

Percolation / Soil Test from ODEQ, if applicable – contact (405) 702-6222

**Site Plan** of entire property, including the following information:

- -Drawn to scale of no greater than 1 in. = 100 ft. on no less than  $8.5'' \times 11''$  paper
- -Physical address of property
- -Vicinity map
- -Easement(s) and/or right(s) of way, with widths
- -Property/lot lines with dimensions, location of proposed structure, and location and square footage of all existing structures
- -Building lines showing all required setbacks for front, side, and rear yards
- -Center line and width of adjacent streets
- -Driveway location and length
- -North arrow for reference

**Storm Water Site Development Plan**—if applicable, in accordance with the City of Blanchard's Erosion Control Ordinance #2004-17, as well as all ODEQ storm water regulations

Floodplain Development Permit Application, if part of construction site is located in the floodplain

**Driveway Permit Application**, if intersecting a section line road

**Plan Review Fee** – \$100.00 Single Family \$150.00 Duplex

### **Building Inspections:**

- 1. 24 hours notice required for all inspection requests Call (405) 485-9392
- 2. A contractor licensed with the State of Oklahoma and the City of Blanchard must request inspections for the following:
- Electrical -- Temporary Pole, Rough-In, Temporary Electric Final, Final
- Plumbing -- Ground, Top-Out, Final
- Mechanical -- Ground, Top-Out, Final
- Roofing
- 3. The builder must request foundation, frame, and final building inspections.

All required inspections must be passed before the final inspection may be conducted and a Certificate of Occupancy issued. An Occupancy Permit is required upon completion of structure and after all other required inspections have been conducted and passed by the City Inspector.

Any permits issued in violation of any ordinance or statute shall be void and no rights or immunities shall be acquired thereby. Nothing in the permit shall be construed to convey or impair the City's rights of maintenance and repair of its utility easements. Destruction of any permanent or temporary structure placed on or over any of the City's easements by virtue of this permit which is occasioned by said maintenance or repair shall be at the expense of the permit holder, his/hers heirs, or assigns.

Please call (405) 485-9392 to schedule an inspection. The cost of the inspections is included in the cost of the building permit.

<u>Sewer Lines</u> - Building/developers are responsible for checking the elevation of sewer lines for adequate gravity flow. If sanitary sewer hookup in not available, a percolation test must accompany the building permit application.

#### **Before Beginning Work**

- Post address and building permit in the front yard or entrance to property. Failure to do so ma delay inspections
- Call Okie One 1-800-522-6543 for free utility locates and spots prior to digging.
- Absolutely NO construction, footing sinpections, and/or pours will be allowed without an approved building permit.

#### Note

The electric and gas company will NOT set a temporary or permanent meter unless it has been released by the City of Blanchard. All builders and property owners are responsible for locating the pins and marking the property/lot lines on building locations.
