

ORDINANCE NO. 715

AN ORDINANCE OF THE CITY OF BLANCHARD, OKLAHOMA AMENDING SECTIONS 21-712, 21-732, AND 21-742, ALL IN ARTICLE 7 OF CHAPTER 21 OF THE BLANCHARD MUNICIPAL CODE PERTAINING TO THE PERMITTED USES FOR THE MEDICAL MARIJUANA INDUSTRY; DECLARING REPEALER; PROVIDING FOR SEVERABILITY; AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BLANCHARD, OKLAHOMA:

SECTION 1. That Chapter 21, Article 7, Section 21-712 "USES PERMITTED" of the Code of Ordinances of the City of Blanchard, Oklahoma, is hereby amended to add the following to the table of Permitted Uses in the A-1 Zoning District:

SECTION 2. That Chapter 21, Article 7, Section 21-732 "USES PERMITTED" of the Code of Ordinances of the City of Blanchard, Oklahoma, is hereby amended to add the following to the table of Permitted Uses in Commercial Zoning Districts:

SECTION 3. That Chapter 21, Article 7, Section 21-742 "USES PERMITTED" of the Code of Ordinances of the City of Blanchard, Oklahoma, is hereby amended to add the following to the table of Permitted Uses in Industrial Zoning Districts:

SECTION 4. REPEALER. All former ordinances or parts of ordinances conflicting or inconsistent with the provisions of this ordinance are hereby repealed.

SECTION 5. SEVERABILITY. In the event any word or sentence in this ordinance, or provision or portion of this ordinance, or rules adopted by this ordinance is invalidated by any court of competent jurisdiction, the remaining words and/or sentences, provisions, or portions thereof shall not be affected and shall continue in full force and effect.

SECTION 6. EMERGENCY. Whereas, it being immediately necessary for the preservation of the public health, peace and safety of the City of Blanchard and the inhabitants thereof, an emergency is hereby declared to exist, by reason whereof, this Ordinance shall be in full force and effect from and after its passage and approval, as provided by law.

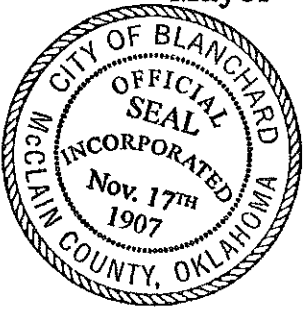
