Animal Cruelty Prevention Month



Preventing animal cruelty starts with responsible pet ownership. The month of April is Animal Cruelty Prevention Month. Cruelty may include but not limited to animal *neglect* of unreasonable deprivation of necessary food, care or shelter or *inhumane treatment* includes, but is not limited to, the following:

- Any physical punishment inconsistent with the health of such animal;
- Lack of food or water for more than a twenty-four (24) hour period;
- Knowingly permitting obvious nutritional deficiencies or other evident health problems involving any animal;
- Improper use of any collar or harness or a fixed leash for the purpose of confining any animal which results in flesh laceration, obvious pain or to cause choking to such animal;
- Depriving animal of adequate shelter; and
- Inhumane killing or attempting to kill any animal.

You can report instances of animal cruelty to the City of Blanchard to be investigated by calling 485-9392.

Child Care Guidelines

Effective immediately, child care providers are requested to implement the following guidance, consistent with new requirements in accordance with federal guidance and <u>Governor Kevin Stitt</u> recent disaster declaration:

---Prohibit any person except the following from accessing an operation: operation staff; persons with legal authority to enter, including law enforcement officers, state child care licensing staff, and Department of Human Services' Family and Protective Services staff; professionals providing services to children; children enrolled at the operation; and parents or legal guardians who have children enrolled and present at the operation.

---Require pickup and drop-off of children outside of the operation, unless it's determined that there is a need for the parent to enter an operation.

---Before allowing entry into the operation, screen all individuals listed above, including taking the temperature of each person upon arrival at the operation each day, and deny entry to any person who meets any of the following criteria:

✓ A temperature of 100.4°F or above.

☑ Signs or symptoms of a respiratory infection, such as a cough, shortness of breath, sore throat, and low-grade fever.

☑ In the previous fourteen (14) days has had contact with someone with a confirmed diagnosis of COVID-19; is under investigation for COVID-19; or is ill with a respiratory illness.

 \blacksquare In the previous fourteen (14) days has travelled internationally to countries with widespread, sustained community transmission. For updated information on affected countries, visit the <u>CDC</u>.

Provide each child with individual meals and snacks. Do not serve family style meals.

Curbside Bulky Waste

Effective Monday, April 6th, 2020, the temporary suspension of Residential Bulk & Brush services, along with limiting Residential Trash services to collection of only contents within carts. Bags and bundles that are placed outside of carts will be excluded from collection during this time, in order to minimize the risk of exposure through manual collection or "pickup by hand". The change to go "cart only" on Residential Routes will be in effect for the ensuing weeks, through April, 2020.

Waste Connections understand that limiting collection services to cart contents only warrants some discretion among residents for what they dispose of and when. Household trash, bags from kitchens and restrooms, should remain a top priority for those waste streams that go into the carts. That's to say, if there is only enough room in the cart remaining for one bag from the kitchen or one bag of yard trimmings, residents are urged to use the space for the bag from the kitchen for health and sanitation purposes.

Now is also a good time to educate customers to bag and tie their household trash, a commonly overlooked best practice. Household trash that is not properly bagged and tied is susceptible to spills and further increases the risk of exposure for Waste Connections personnel to potentially infectious waste.

They appreciate your understanding as they take precautions to protect the health and well-being of their employees, their customers, and their communities. Please trust that they recognize their essential role in maintaining health and sanitation in our communities. Supporting our municipal partners remains one of their highest priorities, right after the safety of their people, and they hope that is evident in their phased approach to plans for continuity of their operations.

However, the City's Citizens Collection Center is open Monday thru Friday from 3:30 p.m. to 6:00 p.m. and Saturday from 8:00 a.m. to 12 Noon. Easter Sunday

Many Christians celebrate Easter Sunday as the day of Jesus Christ's resurrection, which is written in the New Testament of the Christian bible. According to the Gospel of John in the New Testament, Mary Magdalene came to the tomb where

Jesus was buried and found it empty. An angel told her that Jesus had risen. Christians worldwide have celebrated Easter for centuries.



However, the roots of the Easter holiday's traditions and activities can be traced back to pagan celebrations. The name Easter is believed to come from *Eostara*, the goddess of rebirth. In early times the Feast of Eostara celebrated earth's resurrection and rebirth. Strict Puritans would have nothing to do with Easter – it was

merely a human institution – in the past. Charles I, king of England, declared the day as scriptural as Sunday in 1647 but Parliament contradicted him in print and abolished it with other church festivals.

<u>The Easter date</u> depends on the ecclesiastical approximation of the March equinox. In 325CE the Council of Nicaea decided that the Easter date would be the first Sunday after the first full moon occurring on or after the <u>March equinox</u>. Easter is therefore delayed one week if the full moon is on Sunday, which lessens the likelihood of it falling on the same day as the Jewish Passover. Eastern Orthodox churches in many countries such as Greece still figure <u>their Easter date</u> based on the Julian calendar.

Easter eggs and the Easter Bunny are both fertility symbols, holdovers from the feast of Eostara. Other symbolic parallels include the pagan joy in the rising sun of spring, which coincides with Christians' joy in the rising Son of God, and the lighting of candles in churches, which corresponds to the pagan bonfires. The symbol of the cross and images of Jesus Christ, through paintings or statues, are remembered on Easter Day. Easter is Sunday, April 12th.

A deposit sum of \$150.00, which may be in the form of a check written on the bidder's business account made payable to the Architect, will be required for each set of Contract Documents. Digital versions of Documents are available on CD for a nonrefundable deposit of \$25.00.

Bidders may obtain a maximum of two (2) sets of Drawings and Specifications by deposit and additional sets by paying printing costs (\$3.00/sheet for Drawings -\$0.15/page for Specifications). Deposits will be refunded to Bidders who submit a bona fide Bid at the time and place designated herein and who return the Bidding Documents to the Architect in good condition within ten (10) days from the bid date. The full and complete replacement cost of missing, damaged or unreturned Bidding Documents will be deducted from the Bidders deposit. The full replacement cost for complete sets of Bidding Documents will be deducted from the deposits of Bidders who do not submit a bona fide Bid and do not return the Bidding Documents to the office of the Architect in good condition within five (5) days from the date they received them or no later than seven (7) days prior to bid date. Bidding Documents shall be returned to the Architect's Office postage paid. The Architect will not accept delivery of Bidding Documents returned C.O.D., freight collect or other similar methods. Subcontractors and Suppliers may obtain full or partial sets of Bidding Requirements and Documents directly from the Architect by paying the printing costs specified above. All Bidding Requirements and Documents remain property of the Architect.

The Bidding Documents are on file at the Architect's office and are available and open for inspection by Bidders and Sub bidders by appointment during normal business hours.

In submitting a bid it is agreed that the Bid may not be withdrawn for a period of thirty (30) days after Bid Date.

A Bid Security in the form of a cashier's check, or certified check, or acceptable bidder's surety bond, made payable to the Owner, in an amount that is not less than five percent (5%) of the Bid proposal submitted, including all Alternates, shall accompany each Bid as a guarantee that: (1) the Bidder will not modify, withdraw or cancel the proposal for thirty (30) days after the bid date; and (2) the bidder, if awarded the contract, will promptly enter into a contract and execute such bonds and furnish such insurance certificates as may be required. Should the Bidder fail to honor these two (2) guarantee for any reason, the Owner shall total his damages and shall deduct the amount of such damages from the Bidder's Bid Security, should the damages total less than the amount of the Bid Security, the difference shall be returned to the Bidder. However, all damages in excess of the Bid Security shall be borne by the Owner. Request for Proposals

Proposals are being accepted for cutting and baling vegetation growing on properties owned by the Blanchard Municipal Improvement Authority (BMIA). Proposals must be all inclusive; properties are located at the Northwest corner of Tyler Avenue and 280th Street (consisting of approximately 43 .5 acres), and the Blanchard Waste Water Treatment property (approximately 58.5 acres) on 7th Street SE. Bidders shall provide their own equipment for cutting and baling the properties; will be required to sign a written agreement with the BMIA and shall comply with any requirement of City Code regarding Hay Harvesting. The written agreement is available at City Hall. Interested parties shall contact Chris Wittenbach, Parks Director at 405-485-9392 to make arrangements to visit the sites prior to submitting a proposal.

All proposals shall be marked "Haying Proposals" and must be received by the City Clerk at 122 North Main Street – Blanchard, OK 73010 on or before 10:00 a.m. on April 24, 2020. The City of Blanchard reserves the right to reject any and all proposals.

Sales Tax Collections

The City's April Sales Tax collections are \$228,306.16 or -13.96% BELOW the monthly budget projections. This is the 7th straight month that our sales tax collections are below the monthly budget. A total of 9 out of 10 months in this fiscal year are below the budget at -11.27% overall.

SBA Loan Info

Blanchard Businesses Now Eligible to Apply for SBA Economic Injury Disaster Loans

Blanchard businesses affected by the Coronavirus (COVID-19) are now eligible to apply for the SBA Economic Injury Disaster Loan. The U.S. Small Business Administration is offering low-interest federal disaster loans for working capital to Oklahoma small businesses suffering substantial economic injury as a result of COVID-19.

The funding for the loans will be provided by the Coronavirus Preparedness and Response Supplemental Appropriations Act that was recently signed by President Trump.

To qualify for the program, the state must submit documentation of business losses for at least five (5) businesses per county.

If approved, an SBA Economic Injury Disaster Loan assistance declaration will make disaster loans of up to \$2 million available to small businesses and private, nonprofit organizations to help alleviate economic injury caused by COVID-19.

According to the SBA, these loans may be used to pay fixed debts, payroll, accounts payable and other bills that cannot be paid because of the impact of COVID-19. The interest rate is 3.75% for small businesses without credit available elsewhere and 2.75% for nonprofits. Businesses with credit available elsewhere are not eligible for this program.

Shelter Registration

The Blanchard Emergency Management would like to take this opportunity to remind everyone that severe storm season is fast approaching. We want to express how important it is for everyone to register their home's storm shelters and safe rooms. The City of Blanchard storm shelter registry provides emergency services with information that allows them to locate citizens



after a tornado or other natural disaster. Registration helps ensure that people in shelters affected by the storm are able to get help quickly with the potential of shelters' exits being blocked due to debris or structural damage. Registration is doubly important with the possibility of shelters flooding due to broken water lines or simply rain waters entering the shelter and drowning people trapped inside. Registration forms include your address, list of persons who would normally be present at the home and could potentially be in the shelter, the location of the shelter/safe room on the property, and contact information for yourself and an emergency contact. If you have previously registered and some part of your

information has changed, feel free to submit an updated form. If you have a question as to if your shelter is registered please contact the Emergency Management Director/Fire Chief Charlie Largent at the Blanchard Fire Department at 405.485.3939.

Sprinkler Checkup

Conserve water and lower your utility bill by checking your yard sprinkler system for any damage from the winter freezing weather.

✓ Turn on your sprinkler system and walk thru each zone;

Flag any broken pipes or heads for immediate repair;

Make sure sprinkler heads isn't spraying water on hard surfaces such as driveways, sidewalks or the street.

DID YOU KNOW: One broken sprinkler head can waste 25,000 gallons of water in just six (6) months.

Think, Shop, Live Blanchard!

Please keep in mind that Blanchard's quality of life and local economy rely on where residents spend their money and do their shopping. Sales tax is a direct and vital lifeline to essential services like public safety (Police, Fire, 911 services), public facilities, projects, programs and services. Shopping locally keeps businesses here in Blanchard, providing jobs and benefiting community schools and non-profits. If there's one thing we can all do to make our dollars work for this community, it's to shop local! Grab dinner in Blanchard on your way home. You'd be surprised what a difference that can make. Shopping locally benefits the entire community. Make your tax dollars work for you and your community.

Transfer Site

The City of Blanchard operates a Citizen Collection Center for the benefit of citizens of the City of Blanchard and nearby rural areas with a Blanchard address, in order to dispose of household waste and limited other items. The following policies are current to ensure that the site is maintained in accordance with Oklahoma Department of Environmental Quality and the Environmental Protection Agency (EPA) regulations, and with the City's contract with Waste Connections of Oklahoma, Incorporated.

Permits for the Citizen Collection Center are available 'free of charge' for any city residence with a Blanchard address. The cost for bulky waste curbside collection is included your bill for solid waste services. For rural residents outside the city limits, a standard monthly charge of \$13.75 is charged with a Blanchard address and trash service thru Waste Connections. Permits are available at the Blanchard City Hall. Permits are nontransferable.

The hours of operation is Monday through Friday from 3:30 pm to 6:00 pm and Saturdays from 8:00 am to 12 Noon. Please visit the City's website at <u>https://www.cityofblanchard.us/public-utilities/webforms/transfer-station</u> or the City's Facebook to read the Operator's Responsibilities, the acceptable Waste Materials and the unacceptable Waste Materials.

Trash Service

The City contracts with Waste Connections for solid waste collection and disposal of residential trash. For a smooth operation, the following rules should be adhered to: \int Cans need to be set out by 7:00 am;

✓ Carts need to be by the road, at the edge of the driveways, not in the driveway;

 \int If you have multiple carts they need to be three (3) feet apart;

✓ Carts need to be five (5) to seven (7) feet from mailbox, cars, etc;

 \int If carts are placed with wheels toward the house they are less likely to blow over;

✓ No bungee cords, straps, or rope to be placed on your cart, if it is windy, you can place a rock or brick on the lid to keep it closed;

✓ No limbs or trees or hazardous materials in either polycart.

Unemployment Figures

The most recent unemployment rate was released for February. Obviously, these numbers do not take into account our current situation. But, they are useful for benchmarking purposes to understand where Oklahoma City Metro was prior to the significant new UI (Unemployment Insurance) claims.

For the month of February, Oklahoma City MSA unemployment (2.7%) improved slightly from the previous month (January 2.9%). Unemployment rates were lower than a year earlier in 54 of 77 counties in Oklahoma, higher in 19 counties, and unchanged in 4 counties.

The OKC Metro had the 5th lowest unemployment rate of all large metros (over 1 million population) in the country. Last month the OKC Metro ranked 8th. Miami had the lowest unemployment rate (2.3%).

For February:

- Oklahoma County unemployment was 2.7% (improved from 3.0% prior month).
- McClain County unemployment was 2.5% (improved from 2.8% January)
- Grady County unemployment was 3.2% (improved from 3.5% January)
- State of Oklahoma unemployment was 3.2% (improved from seasonally adjusted 3.3% prior month).
- United States unemployment was 3.5% in February (slight improvement from 3.6% prior month). Preliminary March unemployment rate was recently reported at 4.4%.
- Tulsa MSA unemployment was 3.0% (slight increase from 3.2% prior month).

The release dates for metro and county level unemployment will be:

- March Unemployment release (April 29, 2020)
- April Unemployment release (June 3, 2020)
- May Unemployment release (July 1, 2020)

Use Tax Collections

The City's April Use Tax collections were \$86,464.86 or 7.68% ABOVE the monthly budget projections. Overall the use tax collections for the fiscal year are up over the budget by 44.15%.
