#### ADVERTISEMENT FOR BIDS

Notice is given that the Blanchard Municipal Improvement Authority will receive sealed bids in the Office of the Purchasing Agent, Blanchard City Hall, 122 North Main, Blanchard, Oklahoma, until 1:00 PM on March 18, 2021, for:

Waterline and Sanitary Sewer Improvements, King Row to Oak Dr. along US-62.

Bids received more than ninety-six (96) hours, excluding Saturdays, Sundays and holidays, before the time set for opening of bids, as well as bids received after the time set for opening of bids, shall not be considered and shall be returned unopened. Bids shall be made in accordance with this Advertisement for Bids, the plans and specifications, and the bid forms, which are on file and available for public examination at the Office of the Purchasing Agent at City Hall at the address listed above.

Complete sets of general conditions, plans, specifications, and other bidding documents may be obtained at the Morris Engineering and Surveying office, 617 NW 27<sup>th</sup> St., Moore, OK 73160, please call ahead 405-912-2775.

Plans and specifications may be purchased for One Hundred Dollars (100.00) per set. Purchases are nonrefundable. Digital copies are free and will be emailed upon request.

Bids filed with the Purchasing Agent shall be opened publicly and read aloud at City Hall at the time stated above or later. The City shall consider all bids prior to the award of the contract on or before <u>March</u> <u>23, 2021</u>, to the lowest and best bidder meeting specifications and time schedule.

Sales Tax Exemption. Title 68, Oklahoma Statutes (1991), Section 1356(1), exempts sales to municipalities and their contractors from sales taxes on the sale of "tangible personal property or services." All bids for Authority projects shall be assumed to have been made based on such statutory exemption as effective on the bid date.

The bidder <u>must</u> use the Authority's bid forms and affidavits, and all forms must be signed and notarized/attested. The bidder must file the bid in a sealed envelope. The envelope must bear a legible notation thereon stating that it is a bid for the project proposed. The bid must be filed with the Purchasing Agent at Blanchard City Hall. All bids must be typewritten or in ink.

The following documents comprise the complete bid package and must be submitted. Incomplete bid packages will be rejected.

- 1. Blanchard standard bid bond <u>or</u> surety bid bond form.
- 2. Certification of Pre-bid Site Inspection, a letter acknowledging such from Bidder.
- 3. Statement of Bidder's Qualifications.
- 4. A letter from the bidder of previous projects.
- 5. Business Relationships Affidavit, Bid Affidavit.
- 6. Non-Collusion Affidavit.
- 7. ALL Addendum Acknowledgment(s) (if applicable).


#### Carbon-monoxide Warning

### Real ID



Oklahoma has recently begun distributing licenses which will satisfy the REAL ID

standards for Oklahoma residents. In October all persons boarding commercial planes or entering federal facilities, including military bases, will be required to present a REAL ID compliant card. If you already hold a passport or military ID then your identification will meet these

standards. State residents are not required to obtain an Oklahoma REAL ID. However, if you plan to fly, even on domestic airlines, federal law requires that you must possess a REAL ID compliant license. The state has provided a resource for educating residents on the implementation of REAL IDs. ### Tax Payment Deadline

Oklahomans now have until June 15, 2021 to pay their 2020 individual and business income taxes, and their first quarter 2021 estimated income tax payments. As a result of the recent disaster declaration issued by FEMA,

the IRS announced the tax deadline extension for all individuals who reside or own a business in all of Oklahoma's 77 counties to provide relief for those affected by February's historic winter storms. Following the announcement from the IRS, the Oklahoma Tax Commission ordered the payment deadline extension to provide further relief to Oklahoma taxpayers. The Oklahoma Tax Commissioners elected to adjust the payment deadline extension from April 15 to June 15 for all individuals that reside or own a business in Oklahoma.

Due dates for other tax types, including sales and withholding, remain the same. For more information, visit the Oklahoma Tax Commission website.
