Shop Local

Here's what happens when you "shop local."

1. For every \$100 you spend at locally owned businesses, \$68 stays in Blanchard. What happens when you spend that same \$100 at a national chain? Only \$43 stays in the community.

- 2. You wouldn't want your house to look like everyone else's in the U.S. So why would you want your community to look that way?
- 3. Local businesses are better at creating higher-paying jobs for your neighbors. When you shop locally, you help create jobs for firemen, police officers, and many other essential professions.
- 4 Buying from a locally owned business conserves energy and resources in the form of less fuel for transportation and less packaging.
- 5 Local business owners know you, and you know them. Studies have shown that local businesses donate to community causes at more than twice the rate of chains.
- 6. Shopping in a local business district means less infrastructure, less maintenance, and
